Our program objective is to help young people build healthy habits, critical thinking and thoughtful online behavior necessary to integrate technology into their lives in a constructive way. My Digital TAT2 facilitates conversations between students, parents, educators and health care providers that inspire safe, ethical, and conscious digital use by educating them about their power and responsibility in our connected world. For the year ending June 30, 2021, My Digital TAT2 schools closed and struggled to transition to online, our team was available and invested time in creating free resources such as infographics, articles, and webinars for parents/trusted adults and teachers. We created over 33 new pieces of material to share online and with our school communities. We hired 6 diverse educators from around the world. This is the first time we have hired this many hourly staff to help us in the classroom and it is certainly the first time they could work remotely from places like Ohio, Maryland, Riverside, and even Guatemala! For the first time in our 10-year history, we documented our curriculum into lesson plans that have aided in training our new cohort of educators. We learned to master the zoom workshop/intervention. All summer we offered free programming to school aged children both so that they had a place to learn about how to be safe, responsible, and kind online; yet also to learn how best to use zoom in the classroom. We find that our zoom based online interventions can often be stronger and more impactful than in-person ones. Out of 35 nonprofits, My Digital TAT2 was selected to join the new 2021 cohort for All Stars Helping Kids - a foundation that was created by 49er Ronnie Lott to help low income and homeless youth. They value our work around digital resiliency and digital wellness and are making a 3-year investment in us to help us scale. In addition to the funding, we are working with them to create a Theory of

Change and a strategic plan to drive our plans to scale and triple the number of
